Emergency Political Repatriation and Relocation	<p>LACERA has priority access to emergency political evacuation services. All services and payments must be arranged Europ Assistance and iJET Intelligent Risk Systems and must be ordered by an authorized representative of LACERA to certify severity of political situation warrants emergency evacuation/repatriation. All transportation arrangements must be by the most direct and economical route possible.</p>
Emergency Political Repatriation	<p>When it applies:</p> <ol style="list-style-type: none"> 1. Officials of the residence recommend that persons leave the country 2. Employee expelled or declared persona non grata 3. Complete seizure, confiscation or expropriation of property, plant or equipment by the authority of the recognized government of country
Emergency Relocation	<p>Coverage:</p> <p>Return of an employee who has been the subject of an emergency political repatriation to the country from which the employee was expatriated</p> <p>The return of an employee to an employee's resident country</p>
