The meeting was called to order by Chairman Robbins at 11:30 a.m.

I. APPOINTMENT OF VOTING MEMBER(S) IN THE EVENT ONE OR MORE REGULAR COMMITTEE MEMBERS ARE ABSENT

All regular members of the Committee were present.

II. APPROVAL OF THE MINUTES OF THE SPECIAL MEETING OF SEPTEMBER 6, 2012

A motion was made by Mr. de la Garza, seconded by Mr. Adams, to approve the minutes of the special meeting of September 6, 2012. The motion passed unanimously.

III. ACTION ITEMS

- A. Recommendation as submitted by Cynthia Lau, Legislative Affairs Officer: That the Committee recommend the Board of Retirement direct LACERA's voting delegate to support the inclusion of legislative proposals in the SACRS 2013 Legislative Platform. (Memorandum dated October 1, 2012)
 - 1) LACERA Proposal to Address Use of Telephone Transactions would further amend existing Government Code Section 31527 to allow county retirement systems to adopt, at their election, regulations allowing for the secure processing of member requests by telephone with the same force and effect as a manual signature.

A motion was made by Mr. de la Garza, seconded by Mr. Kehoe, to direct LACERA's voting delegate to support the inclusion of this proposal in the SACRS 2013 Legislative Platform. The motion passed unanimously.

2) LACERA Proposal to Address Disclosure of Real Estate Investments – would exempt "non-publicly traded direct or indirect real estate investments" from disclosure under the California Public Records Act (CPRA).

> A motion was made by Mr. Russin, seconded by Mr. Morris, to direct LACERA's voting delegate to support the inclusion of this proposal in the SACRS 2013 Legislative Platform. The motion passed unanimously.

3) SJCERA Proposal to Address Alternative Investments and Public Disclosure – would add Government Code Section 6254.26 of the CPRA to the list of writings which are exempt from public disclosure under the Brown Act, and would also allow a Board to be able to hold a closed session to discuss information relating to its alternative investments which are already exempt under Section 6254.26 of the CPRA.

A. Staff Activities Report for September, 2012

The staff activities report was discussed.

B. LTC Update

When Met Life exited the long term care market, your Committee directed staff to issue an RFP for a new long term care plan. We have postponed issuing that RFP due to the instability of the long term care market. However, even though the market is still in flux and we likely won't be able to find a plan that duplicates the benefits of the Met Life or Transamerica plans, staff plans to issue a Request for Information (RFI) to see what is actually available. Also, we are still seeking to include the active population in the LACERA sponsored plan. After the County has reviewed the draft RFI and decides whether they want to join us, we will move forward with the RFI.

C. EGWP Update

Aon presented an update on the EGWP feasibility study. Data has been requested from Anthem Blue Cross and Caremark to gather the necessary information. Part of the study is to look at the drug claims currently being paid, what drugs are being used, and compare to Medicare Part D to see what wraparound benefits would need to be added to equal the benefits currently being offered. Switching to EGWP would ultimately replace the RDS program and potentially provide substantial savings for LACERA.

D. Reserve Analysis Update

Aon reported on the analysis of the reserves held by Anthem Blue Cross and CIGNA. In the past, at the direction of the County, these funds have been used to defray future premium increases in years where the insured plans generated deficits. Also, reserves have been used to fund premium holidays for Anthem and CIGNA members. Aon is reviewing the adequacy and appropriateness of use of these accounts, both within and outside of LACERA's insurance contracts. Data gathering from the carriers and LACERA is under way, with the expected completion date by the November Committee meeting.

E. CIGNA & Anthem Blue Cross Claims Experience

The CIGNA & Anthem Blue Cross Claims Experience reports through August 2012 were discussed.

F. Health Insurance Exchanges

Aon discussed an article which appeared in the Wall Street Journal. Two big employers have signed on to a corporate health care exchange. In general, it is a defined contribution approach, wherein active employees will be given a set amount of money and they will select among an array of individual health insurance options. This is starting in corporate America, but if this truly takes hold in the country, it will come back to the public sector and will have to be addressed as it relates to retiree health care.
