 - A. CMS Early Retiree Reinsurance Program (ERRP) Final Audit Report

The Early Retiree Reinsurance Program (ERRP) was included in the Patient Protection and Affordable Care Act (the ACA) enacted on March 23, 2010. This is a temporary program in which Congress appropriated \$5 billion to provide financial assistance to plan sponsors that provide health coverage to early retirees (those age 55 through 64) and their families. Our participation in this federal program has resulted in LACERA receiving approximately \$12 million in ERRP funds.

On June 18, 2013, staff received written notification from the Department of Health & Human Services that the Centers for Medicare and Medicaid Services (CMS) would be conducting an audit of LACERA's participation in the Early Retiree Reinsurance Program (ERRP). The objective of the audit was to determine compliance with the program statute, rules and guidance.

On September 26, 2014, staff received notice that CMS had completed their audit of LACERA's participation in the ERRP program. CMS' final audit findings determined that an overpayment to LACERA had occurred, and we are in the process of submitting a wire transfer to satisfy that debt.

Given the size and scope of the ERRP, and the number of eligible LACERA members, staff is generally pleased with the performance reported by the CMS audit. Staff considers the findings to be minor, and we have addressed and corrected the issues.
